Jem and Jean Louise Finch (better known as Scout) are the children of a highly respected lawyer, Atticus Finch. 'All I could see was a frightening dark shadow attacking me, then my brother tried to stop him from behind and then he pushed me to the ground and turned to my brother. That's when he broke Jem's arm. I was so scared, I couldn't do anything,' Jean Louise stated in an interview.

Mr. Heck Tate, the County's Sheriff, stated that medical results revealed there was positive alcohol reading in Ewell's blood. It is also thought that after Ewell broke Jem's arm, he tripped and fell on his own knife which resulted in his death.

One of the Finch's neighbours, Ms Stephanie Crawford, has confirmed she saw a suspicious person carrying Jem Finch home while Jean Louise running behind.

After a tiring night, the Finch children are recovering from their terrifying experience. Mr finch is relieved that he still has his two beloved children. The suspicion that another person was at the scene has been dismissed by Sheriff Heck Tate.
